MAHARASHTRA ORDINANCE No. XVI OF 2014.

AN ORDINANCE

further to amend the Maharashtra Universities Act, 1994.

WHEREAS both Houses of the State Legislature are not in session;

Mah. AND WHEREAS the Governor of Maharashtra is satisfied that XXXV of circumstances exist which render it necessary for him to take immediate action further to amend the Maharashtra Universities Act, 1994, for the purposes hereinafter appearing;

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of article 213 of the Constitution of India, the Governor of Maharashtra is

- 1. (1) This Ordinance may be called the Maharashtra Universities commencement. (Amendment) Ordinance, 2014.
 - (2) It shall come into force at once.

Amendment XXXV of

2. In the Schedule to the Maharashtra Universities Act, 1994, in Part Mah of Schedule I, in entry 2, in column (2), for the words "The University of Pune", the XXXV of to Mah. words "The Savitribai Phule Pune University" shall be substituted.

STATEMENT

The Management Council of the Pune University has, considering the precious and valuable work and as well as great effort and reputation of Smt. Savitribai Phule in the field of Education and Women Education and in order to keep hard exemplary and ideas before the future generation, by its resolution, recommended to the State Government to extend the name of the University of Pune as Savitribai Phule Pune University. The Government has also received various representations from the people's representatives in this regard. After considering the said resolution and representations received in this behalf, the State Government considers it expedient to extend the name the of Pune University as Savitribai Phule Pune University, by amending the Maharashtra Universities Act, 1994 (Mah. XXXV of 1994) suitably.

As both Houses of the State Legislature are not in session and the Governor of Maharashtra is satisfied that circumstances exist which render it necessary for him to take immediate action further to amend the Maharashtra Universities Act, 1994 (Mah. XXXV of 1994), for the purposes aforesaid, this Ordinance is promulgated.
