MAHARASHTRA ORDINANCE No. XXII OF 2018.

AN ORDINANCE

further to amend the Maharashtra Goods and Services Tax Act, 2017.

WHEREAS both Houses of the State Legislature are not in session;

AND WHEREAS the Governor of Maharashtra is satisfied that circumstances exist which render it necessary for him to take immediate action further to amend Mah. the Maharashtra Goods and Services Tax Act, 2017, for the purposes hereinafter XLIII of appearing; 2017.

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of article 213 of the Constitution of India, the Governor of Maharashtra is hereby pleased to promulgate the following Ordinance, namely:-

1. (1) This Ordinance may be called the Maharashtra Goods and Services Short title and Tax (Amendment) Ordinance, 2018.

- (2) Section 1 shall come into force at once.
- (3) Save as otherwise provided, remaining sections shall come into force on such date as the Government may, by notification in the Official Gazette, appoint and different dates may be appointed for different provisions of this Ordinance and any reference in any such provision to the commencement of this Ordinance shall be construed as a reference to the coming into force of that provision.

Amendment of section 2 of 2017.

2. In section 2 of the Maharashtra Goods and Services Tax Act, 2017 Mah. Mah. XLIII of (hereinafter referred to as the "principal Act"),—

- (a) in clause (4), for the words "the Appellate Authority and the Appellate Tribunal" the words, brackets and figures, "the Appellate Authority, the Appellate Tribunal and the Authority referred to in sub-section (2) of section 171" shall be substituted:
- (b) in clause (16), for the words "Central Board of Excise and Customs" the words "Central Board of Indirect Taxes and Customs" shall be substituted;
- (c) in clause (17), for sub-clause (h), the following sub-clause shall be substituted, namely:-
 - "(h) activities of a race club including by way of totalisator or a license to book maker or activities of a licensed book maker in such club; and";
 - (d) clause (18) shall be deleted;
- (e) in clause (35), for the word, brackets and letter "clause (c)" the word, brackets and letter, "clause (b)" shall be substituted;
- (f) in clause (69), in sub-clause (f), after the word and figures "article 371" the words, figures and letter "and article 371J" shall be inserted;
 - (g) in clause (102), the following Explanation shall be inserted, namely:—
 - "Explanation.—For the removal of doubts, it is hereby clarified that the expression, "services" includes facilitating or arranging transactions in securities; ".
- 3. In section 7 of the principal Act, with effect from the1st day of July 2017,—
 - (a) in sub-section (1),—
 - (i) in clause (b), after the words "or furtherance of business;" the word "and" shall be inserted and shall always be deemed to have been inserted;
 - (ii) in clause (c), after the words "a consideration" the word "and" shall be deleted and shall always be deemed to have been deleted;
 - (iii) clause (d) shall be deleted and shall always be deemed to have been deleted;
- (b) after sub-section (1), the following sub-section shall be inserted and shall always be deemed to have been inserted, namely: —
 - "(1A) Where certain activities or transactions constitute a supply in accordance with the provisions of sub-section (1), they shall be treated either as supply of goods or supply of services as referred to in Schedule II.";
- (c) in sub-section (3), for the words, brackets and figures "sub-sections (1) and (2)" the words, brackets, figures and letter "sub-sections (1), (1A) and (2)" shall be substituted.

- "(4) The Government may, on the recommendations of the Council, by notification, specify a class of registered persons who shall, in respect of supply of specified categories of goods or services or both received from an unregistered supplier, pay the tax on reverse charge basis as the recipient of such supply of goods or services or both, and all the provisions of this Act shall apply to such recipient as if he is the person liable for paying the tax in relation to such supply of goods or services or both.".

 - (a) in sub-section (1),—

"Provided further that, a person who opts to pay tax under clause (a) or clause (b) or clause (c) may supply services (other than those referred to in clause (b) of paragraph 6 of Schedule II), of value not exceeding ten per cent. of turnover in the State in the preceding financial year or five lakh rupees, whichever is higher.";

- (b) in sub-section (2), for clause (a), the following clause shall be substituted, namely: ---
 - "(a) save as provided in sub-section (1), he is not engaged in the supply of services;".
- In section 12 of the principal Act, in sub-section (2), in clause (a), the Amendment of words, brackets and figure "sub-section (1) of " shall be deleted.

7. In section 13 of the principal Act, in sub-section (2), the words, brackets Amendment of and figure "sub-section (2) of", at both the places where they occur, shall be deleted.

(a) in clause (b), for the Explanation, the following Explanation shall be of Mah. XLIII substituted, namely:-

"Explanation.—For the purposes of this clause, it shall be deemed that the registered person has received the goods or, as the case may be, services—

- (i) where the goods are delivered by the supplier to a recipient or any other person on the direction of such registered person, whether acting as an agent or otherwise, before or during movement of goods, either by way of transfer of documents of title to goods or otherwise:
- (ii) where the services are provided by the supplier to any person on the direction of and on account of such registered person.";

(b) in clause (c), for the word and figures "section 41" the words, figures and letter "section 41 or section 43A" shall be substituted.

Amendment of section 17 of Mah. XLIII of 2017.

- 9. In section 17 of the principal Act,—
 - (a) in sub-section (3), the following Explanation shall be inserted, namely:—

"Explanation.— For the purposes of this sub-section, the expression "value of exempt supply" shall not include the value of activities or transactions specified in Schedule III, except those specified in paragraph 5 of the said Schedule.";

- (b) in sub-section (5), for clauses (a) and (b), the following clauses shall be substituted, namely:—
 - "(a) motor vehicles for transportation of persons having approved seating capacity of not more than thirteen persons (including the driver), except when they are used for making the following taxable supplies, namely:—
 - (A) further supply of such motor vehicles; or
 - (B) transportation of passengers; or
 - (C) imparting training on driving such motor vehicles;
 - (aa) vessels and aircraft except when they are used-
 - (i) for making the following taxable supplies, namely:—
 - (A) further supply of such vessels or aircraft; or
 - (B) transportation of passengers; or
 - (C) imparting training on navigating such vessels; or
 - (D) imparting training on flying such aircraft;
 - (ii) for transportation of goods;
 - (ab) services of general insurance, servicing, repair and maintenance in so far as they relate to motor vehicles, vessels or aircraft referred to in clause (a) or clause (aa):

Provided that, the input tax credit in respect of such services shall be available,-

- (i) where the motor vehicles, vessels or aircraft referred to in clause (a) or clause (aa) are used for the purposes specified therein;
 - (ii) where received by a taxable person engaged—
 - (I) in the manufacture of such motor vehicles, vessels or aircraft; or
 - (*II*) in the supply of general insurance services in respect of such motor vehicles, vessels or aircraft insured by him;
- (b) the following supply of goods or services or both—
 - (i) food and beverages, outdoor catering, beauty treatment, health services, cosmetic and plastic surgery, leasing, renting or hiring of motor vehicles, vessels or aircraft referred to in clause (a) or clause (aa) except when used for the purposes specified therein, life insurance and health insurance:

Provided that, the input tax credit in respect of such goods or services or both shall be available where an inward supply of such goods or services or both is used by a registered person for making an outward taxable supply of the same category of goods or services or both or as an element of a taxable composite or mixed supply;

- (ii) membership of a club, health and fitness centre; and
- (iii) travel benefits extended to employees on vacation such as leave or home travel concession:

Provided that, the input tax credit in respect of such goods or services or both shall be available, where it is obligatory for an employer to provide the same to its employees under any law for the time being in force.".

10. In section 20 of the principal Act, in the Explanation, in clause (c), for the Amendment of words and figures "under entry 84" the words, figures and letter "under entries 84" and 92A" shall be substituted.

- 11. In section 22 of the principal Act, —
- (a) in sub-section (1), after the proviso, the following proviso shall be inserted, namely:-

"Provided further that, the Government may, at the request of a special category State and on the recommendations of the Council, enhance the aggregate turnover referred to in the first proviso from ten lakh rupees to such amount, not exceeding twenty lakh rupees and subject to such conditions and limitations, as may be so notified.";

- (b) in the Explanation, in clause (iii), after the word "Constitution" the words "except the State of Jammu and Kashmir and the States of Arunachal Pradesh, Assam, Himachal Pradesh, Meghalaya, Sikkim and Uttarakhand" shall be inserted.
- **12.** In section 24 of the principal Act, in clause (x), after the words "commerce Amendment of operator" the words and figures "who is required to collect tax at source under section 52" shall be inserted.

"Provided that, during pendency of the proceedings relating to cancellation of registration filed by the registered person, the registration may be suspended for such period and in such manner as may be prescribed.":

(c) in sub-section (2), after the proviso, the following proviso shall be inserted, namely:-

"Provided further that, during pendency of the proceedings relating to cancellation of registration, the proper officer may suspend the registration for such period and in such manner as may be prescribed.".

> "Provided that, nothing contained in this sub-section shall apply to any department of the Central Government or a State Government or a local authority, whose books of account are subject to audit by the Comptroller and Auditor-General of India or an auditor appointed for auditing the accounts of local authorities under any law for the time being in force.".

 - (a) in sub-section (1),-
 - (i) for the words "in such form and manner as may be prescribed" the words "in such form, manner and within such time as may be prescribed "shall be substituted;
 - (ii) the words "on or before the twentieth day of the month succeeding such calendar month or part thereof "shall be deleted;
 - (iii) the following proviso shall be inserted, namely:—

"Provided that, the Government may, on the recommendations of the Council, notify certain classes of registered persons who shall furnish return for every quarter or part thereof, subject to such conditions and safeguards as may be specified therein.";

(b) in sub-section (7), the following proviso shall be inserted, namely:—

"Provided that, the Government may, on the recommendations of the Council, notify certain classes of registered persons who shall pay to the Government the tax due or part thereof as per the return on or before the last date on which he is required to furnish such return, subject to such conditions and safeguards as may be specified therein.";

- (c) in sub-section (9),—
- (i) for the words "in the return to be furnished for the month or quarter during which such omission or incorrect particulars are noticed" the words "in such form and manner as may be prescribed" shall be substituted;
- (ii) in the proviso, for the words "the end of the financial year" the words "the end of the financial year to which such details pertain" shall be substituted.
- After section 43 of the principal Act, the following section shall be inserted, Insertion of namely:-

section 43A in Mah. XLIII of 2017.

(1) Notwithstanding anything contained in sub-section (2) of Procedure for section 16, section 37 or section 38, every registered person shall in the returns furnished under sub-section (1) of section 39 verify, validate, modify or delete the details of supplies furnished by the suppliers.

furnishing return and availing input tax credit.

- (2) Notwithstanding anything contained in section 41, section 42 or section 43, the procedure for availing of input tax credit by the recipient and verification thereof shall be such as may be prescribed.
- (3) The procedure for furnishing the details of outward supplies by the supplier on the common portal, for the purposes of availing input tax credit by the recipient shall be such as may be prescribed.
- (4) The procedure for availing input tax credit in respect of outward supplies not furnished under sub-section (3) shall be such as may be prescribed and such procedure may include the maximum amount of the input tax credit which can be so availed, not exceeding twenty per cent, of the input tax credit available, on the basis of details furnished by the suppliers under the said sub-section.
- (5) The amount of tax specified in the outward supplies for which the details have been furnished by the supplier under sub-section (3) shall be deemed to be the tax payable by him under the provisions of the Act.
- (6) The supplier and the recipient of a supply shall be jointly and severally liable to pay tax or to pay the input tax credit availed, as the case may be, in relation to outward supplies for which the details have been furnished under sub-section (3) or sub-section (4) but return thereof has not been furnished.
- (7) For the purposes of sub-section (6), the recovery shall be made in such manner as may be prescribed and such procedure may provide for nonrecovery of an amount of tax or input tax credit wrongly availed not exceeding one thousand rupees.
- (8) The procedure, safeguards and threshold of the tax amount in relation to outward supplies, the details of which can be furnished under sub-section (3) by a registered person,—
 - (i) within six months of taking registration;
 - (ii) who has defaulted in payment of tax and where such default has continued for more than two months from the due date of payment of such defaulted amount,

shall be such as may be prescribed.".

In section 48 of the principal Act, in sub-section (2), after the word and Amendment of figures "section 45" the words "and to perform such other functions" shall be inserted.

"Provided that, the input tax credit on account of State tax shall be utilised towards payment of integrated tax only where the balance of the input tax credit on account of central tax is not available for payment of integrated tax;";

"Provided that the input tax credit on account of Union territory tax shall be utilised towards payment of integrated tax only where the balance of the input tax credit on account of central tax is not available for payment of integrated tax;".

Utilisation of input tax credit subject to certain conditions.

"49A. Notwithstanding anything contained in section 49, the input tax credit on account of State tax shall be utilised towards payment of integrated tax or State tax, as the case may be, only after the input tax credit available on account of integrated tax has first been utilised fully towards such payment.

Order of utilization of input tax credit.

49B. Notwithstanding anything contained in this Chapter and subject to the provisions of clause (e) and clause (f) of sub-section (5) of section 49, the Government may, on the recommendations of the Council, prescribe the order and manner of utilisation of the input tax credit on account of integrated tax, central tax, State tax or Union territory tax, as the case may be, towards payment of any such tax.".

- (b) supply of goods by the consignee to any other person, by endorsement of documents of title to the goods, after the goods have been dispatched from the port of origin located outside India but before clearance for home consumption.";

"Explanation 2.—For the purposes of paragraph 8, the expression "warehoused goods" shall have the same meaning as assigned to it in the Customs Act, 1962.".

STATEMENT

The Maharashtra Goods and Services Tax Act, 2017 (Mah. XLIII of 2017) has been enacted with a view to make a provision for levy and collection of tax on intra-State supply of goods or services or both.

- 2. The Act provides for certain provisions for smooth transition of existing tax payers to new goods and services tax regime. However, the new tax regime has faced certain difficulties. One of the major inconveniences caused to the taxpayers, especially small and medium enterprises, is the process of filing the return and payment of tax under the Goods and Services Tax laws. In this regard, the proposed new return filing system envisages quarterly filing of the return and tax payment for small taxpayers along with minimum paperwork. In order to implement the new return filing system, and also to overcome the above difficulties, it is proposed to amend the Maharashtra Goods and Services Tax Act, 2017, suitably.
- 3. (The proposed Maharashtra Goods and Services Tax (Amendment) ordinance, *inter alia*, a provides for the following, namely:—
 - (i) to amend section 7 of the Act, so as to clarify the scope of supply;
 - (ii) to amend section 9 of the Act, for empowering the State Government to notify the classes of registered persons for paying the tax on reverse charge basis, in respect of receipt of supplies of certain specified categories of goods or services or both, from the unregistered suppliers;
 - (iii) to amend section 10 of the Act, so as to enhance the limit of composition levy from one crore rupees to one crore and fifty lakh rupees;
 - (iv) to amend section 17 of the Act, so as to specify the scope of input tax credit;
 - (v) to amend section 22 of the Act, in view of the enhancement in the exemption limit for registration in the special category States from ten lakh rupees to twenty lakh rupees;
 - (*vi*) to amend section 25 of the Act, so as to facilitate tax payer to have the option to obtain multiple registrations for multiple places of business located within the same State and to provide for separate registration for Special Economic Zone unit or developer;
 - (vii) to amend section 29 of the Act, so as to insert a provision for temporary suspension of registration while cancellation of registration is under process;
 - (*viii*) to insert a new section 43A, so as to provide for the new system of filing return and availing input tax credit;
 - (*ix*) to amend sub-section (*6*) of section 107 of the Act relating to Appeals, so as to provide that the amount of pre-deposit payable for filing of appeal shall be capped at twenty five crore rupees;
 - (x) to amend section 129 of the Act, so as to increase the period relating to detention or seizure of goods and conveyance in transit from seven days to fourteen days.

4. As both Houses of the State Legislature are not in session and the Governor of Maharashtra is satisfied that circumstances exist which render it necessary for him to take immediate action further to amend the Maharashtra Goods and Services Tax Act, 2017 (Mah. XLIII of 2017), for the purposes aforesaid, this Ordinance is promulgated.
