AND WHEREAS, instructions from the Government of India, Ministry of Labour and Employment have been received to carry out amendments to the Factories, Act. 1948. Contract Labour (Regulation and Abolition) Act. 1970 and Industrial Disputes Act. 1947.

Now therefore, in light of the instructions received from the Government of India, Ministry of Labour and Employment, be it enacted by the Legislature of the State of Meghalaya in the Seventy-First Year of the Republic of India as follows:-

- 1. (1) This Act may be called the Meghalava Labour Laws (Amendment) Act. 2020.
 - It extends to the whole of the State of Meghalava.
- (3) It shall come into force on such date as the State Government may, by notification, in the Official Gazette appoint.

Amendment of the In clause (m) of Section 2 of the Factories Act, 1948,-Factories Act. 1948

- in the existing sub-clause (i), for the word "ten" appearing therein, the word "twenty" shall be substituted; and
- in sub-clause (ii), for the word "twenty" appearing therein, the word "forty" shall be substituted:
- In sub-section (4) of Section 1 of Contract Labour (Regulation and Abolition) Act, 1970,-
- in the existing clause (a) for the word "twenty" appearing therein.
- in the existing clause (b), for the word "twenty" appearing therein,
- the word "fifty" shall be substituted.
