further to amend the Sikkim Lokayukta Act, 2014.

BE it enacted by the Legislature of Sikkim in the Seventy-fourth Year of the Republic of India, as follows:-

Short title, extent and commencement	1.	(1)	This Act may be called the Sikkim Lokayukta (Amendment) Act, 2023.
		(2)	It shall extend to the whole of Sikkim
		(3)	It shall come into force at once
Amendment of Section 5	2.		In the Sikkim Lokayukta Act, 2014 (hereinafter referred to as the "principal Act"), in section 5, after sub-section (1), the following sub-section shall be inserted, namely:- "(2) The Chairperson and every member shall before entering their office, make and subscribe before the Governor an oath or affirmation in the form set out for this purpose in the Schedule."
Amendment of Section 9	3.		In the principal Act, in section 9, for the existing sub-sections (1) and (2), the following sub-sections shall be substituted, namely:- "(1) There shall be a Secretary to the Lokayukta in the rank of Secretary to the Government of Sikkim who shall be appointed by the chairperson from the panel of names sent by the State Government. (2) There shall be an Inspector of Inquiry and a Public Prosecutor, who shall be appointed by the Lokayukta from the panel of names sent by the State Government."
Insertion of new Section 32 A and 32 B	4		In the principal Act, after section 32, the following new sections shall be inserted, namely:- "32 (A). The State Government may, after due appropriation made by Assembly by law in this behalf, make to the Lokayukta grants of such sums of money as are required to be paid for the salaries and allowances payable to the Chairperson and Members and the administrative expenses, including the salaries and allowances and pension payable to or in respect of officers and other employees of the Lokayukta.
