### **Government Bills passed by Parliament during the Winter Session**

Short Title	Key Objectives
The Bharatiya Vayuyan Vidheyak, 2024*	Replaces the Aircraft Act, 1934, which regulates the civil aviation sector. Retains most provisions of the Act.
The Appropriation (No.3) Bill, 2024**	Authorises additional expenditure from the Consolidated Fund of India for the financial year 2024-25
