Budget Session: January 31, 2025 - April 4, 2025

- ◆ The Budget Session of Parliament is scheduled to be held between January 31, 2025 and April 4, 2025. There will be a total of 27 sittings.
- 12 pending Bills have been listed for consideration and passing. Four Bills have been listed for introduction, consideration and passing. These are listed below:

The Banking Laws (Amendment) Bill, 2024	Amends different banking laws to alter the tenure of directors of co-operative banks, and expand provisions for the settlement of unclaimed amounts.	9 Aug 2024 Lok Sabha	Passed by Lok Sabha Pending in Rajya Sabha
